The Performance Rights are granted to executives and senior employees pursuant to the Company's Long Term Incentive Plan. Each Performance Right carries a right to one fully paid ordinary share.

The performance hurdle for one-third of the performance rights will be based on the executive/senior employees continuing to be an employee of the consolidated entity at the vesting date; thus creating a retention component; and the performance hurdle for the remaining two-thirds of the performance rights will be the TSR Performance Ranking described below.

The performance hurdle for the performance rights is based on the Company's performance ranking over the relevant period (the "Performance Period") determined by reference to the Total Shareholder Return ("TSR") of the Company during the Performance Period as compared to the TSR for each company in a peer group of companies. The peer group of companies comprises the companies listed in the S&P/ASX 300 (ranked by market capitalisation) after excluding resource companies, banks and listed property trusts. A peer company continues to be included in the comparator group for entire Performance Period, except where the company is delisted due to takeover or merger. New entrants into the ASX300 during the performance period are included.

No amount is payable upon the issue or vesting of Performance Rights.


